

Referral Program Terms and Conditions

Definitions: In this Agreement the terms have the following meanings:

1. "Koogar" is the trading style of Amanda Daniels and includes but is not limited to agents and employees.
2. "the Website" is <http://www.koogar.co.uk>.
3. "the Client" means any person, company, partnership, organisation or body to which Koogar agrees to provide Work under the normal terms and conditions.
4. "the Referral Member" means any person, company, partnership, organisation or body to which Koogar accepts as a member of the Referral Program under the terms of this Agreement.
5. "the Referral ID" is the number you receive from Koogar to pass out to potential clients.
6. "the Agreement" is the contract between Koogar and the Referral Member to which these referral program terms and conditions apply.
7. "Account" is the Referral Member placement of referral for Work provided by Koogar.
8. "the Work" means but is not limited to Web Site Design, Web Site Maintenance, Graphic Design, CD ROM Design and Presentation Design and any other service Koogar provides to the Client.
9. "the Project" means the Work being implemented by Koogar for the Client.
10. "Payment" means the sums to be paid by the Koogar to the Referral Member as specified in the referral program terms and conditions, which is to be signed by the Referral Member in consideration of the performance of the Project.

Only registered members of the Koogar Referral Program can claim their commission.

What is required to become a member?

1. Be a registered member of the Koogar Referral Program. Register for free at http://www.koogar.co.uk/referral_program.php
2. Minimum age of 18.

Becoming a member:

Step 1:

- Fill out the on-line form to register to become a Koogar Affiliate.

Step 2:

- Read the below referral program terms and conditions.
- Add your initials to the last box on the form. This means that you have accepted Koogars referral program terms and conditions.

Step 3:

- Receive your unique Referral ID.
- As soon as you have received your Referral ID you are then fully operational as an affiliate of our referral program.

Referral ID

1.0 Affiliates to this program can earn rewards by referring Koogar. Any new client who signs up for services from Koogar must submit your Referral ID right at the beginning of the Project. Your Referral ID must be given to Koogar before the new sign up receives their Order Form.

1.1 Any late Referral ID's given to Koogar will be taken on board at Koogars' discretion.

1.2 By using this code, all sign ups under your Referral ID will be tracked accurately.

Commission

2.0 Affiliates are rewarded a luxury hamper for every 4 successful referrals. The hamper will be delivered to the Referral Member only when the said 4th project has been completed in full.

2.1 You will be able to review your details and referrals you have made in the referral program login area on the Website.

We reserve the right to:

3.0 Terminate any Referral Member for any reason, including but not limited to, fraud or suspected fraud. Fraud includes, but is not limited to, the submission of unauthorized purchases, or providing unsolicited advertisements.

3.1 Deny referral commissions from referred purchases, which are returned for any reason and not reveal the reasons for termination of Referral Members.

From time to time to send e-mail notifications to Referral Members with regard to promotions, or offers.

3.2 In the event that Koogar discontinues its referral program, it will pay all Referral Members the balance of their accounts.

3.3 If your account is terminated, you MUST immediately discontinue using Koogar names and images and representations of Koogar in any manner.

3.4 The commission rate of Referral Members will last as long as this referral program is running.

You as a Referral Member agree to defend and indemnify Koogar and its agents and employees for any and all losses, costs, liabilities or expenses, including without limitation incurred or arising from:

4.0 Any breach of these terms.

4.1 Any user-generated content off our site or

4.2 Any claims arising from the sale or license of goods or services promoted or made available through any promotional campaign you may conduct to gain referrals.

Unsolicited advertising in any form is not condoned in any manner and any Referral Members found to be involved in any type of activities will be terminated without payment compensation.

Koogar reserves the right to amend, modify or vary these referral program terms and conditions from time to time. Notice of any such amendment shall be given to the Referral Member by the publication of modified referral program terms and conditions on the Website and a notice of change will be sent to your registered email address.

All new Referral Members when registering must sign a copy of these referral program terms and conditions. This indicates agreement to and acceptance of these referral program terms and conditions. You can either physically sign a copy of these referral program terms and conditions and send them back to Koogar, or you can fill in our on-line form and put your initials in the final box which also means you have accepted these referral program terms and conditions.
